Our main office is in Buffalo, but our Chautauqua County location is in Dunkirk, New York. We provide legal services to eight counties (Erie, Niagara, Orleans, Genesee, Wyoming, Allegany, Chautauqua & Cattaraugus) and the Seneca Nation.

How do I qualify for services?

Eligibility guidelines vary based on the type of assistance you need. Most of our services are for people who are 60 years old or older, but some services are available to people of all ages with disabilities. Income restrictions may apply. Please call our office for more information.

What if I cannot come to your office?

You can call our office to go through the intake process- you do not have to come in. If we need to meet you in person and you are unable to come in due to a disability or transportation issues, please talk to your attorney/paralegal team about options.
